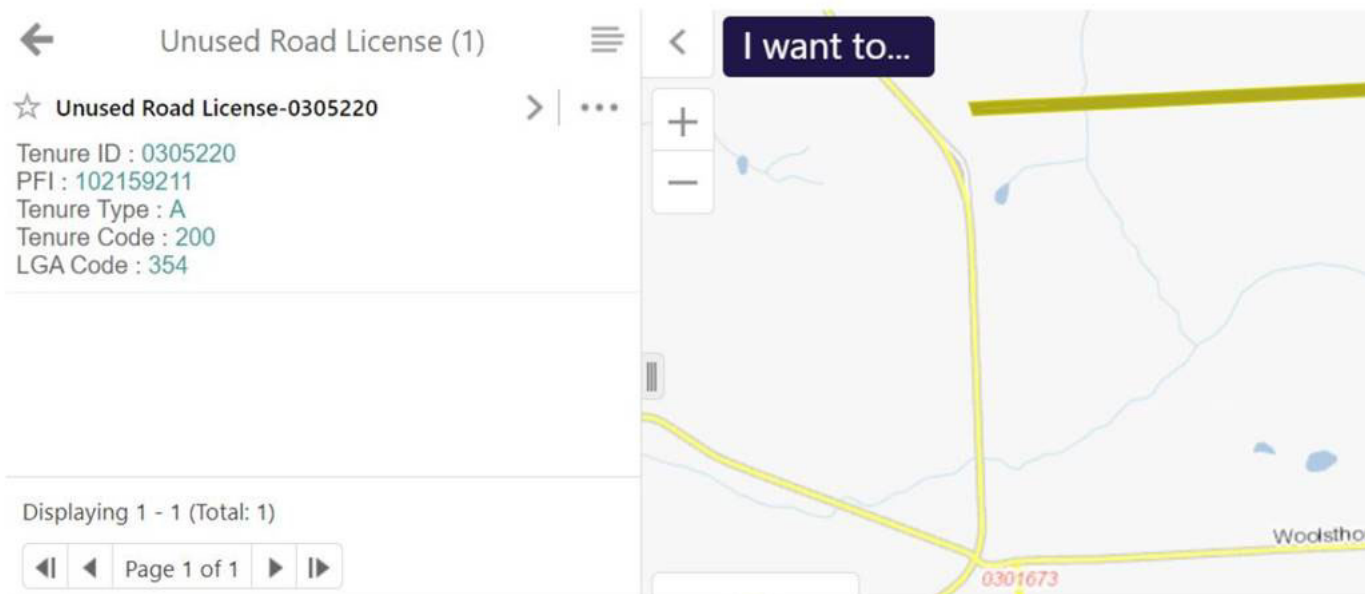
Hi Joanna,

Can you please direct this email to the planner that has been assigned the application.

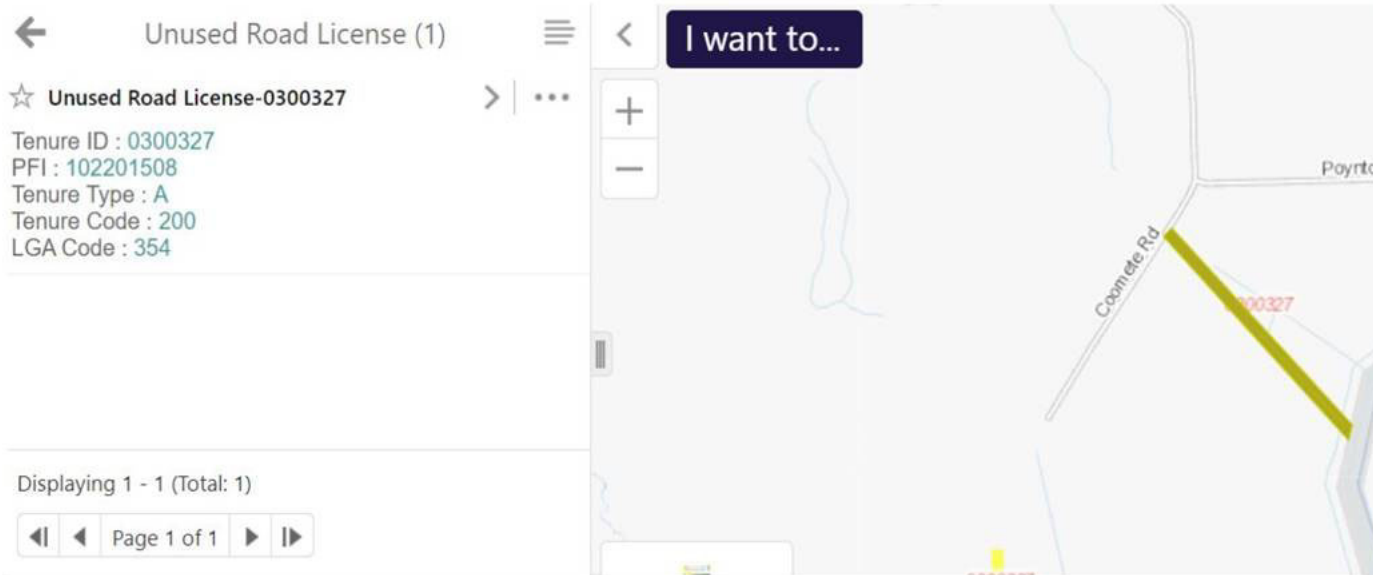
There are two road reserves (crown land) which will be crossed as part of the transmission line. We are aware that we need to get permissions from DELWP to cross these reserves and that there is a Department (separate to planning) that provides these approvals with certain conditions and requirements. Can you please provide the relevant contact details so that we can get in touch with this Department.

For reference, the reserves are below.

The first one is located in the middle of the parcels at the start of the line. It doesn't seem to have a parcel identifier but it is as an 'unused licence road' this means there is a grazing licence from DELWP to the landowner for the use of the road for grazing.



The second one is near Coomete and Poyntons Roads Willatook and is the same, a licence has been granted to the landowner from DELWP. This is also a river crossing.
