## **Amendment of Planning Application PA2000862 5MW Solar Energy Facility and Utility Installations** 4785 Western Highway, Ledcourt (Greentech 1 Pty. Ltd.)

Pursuant to Section 57A of the Planning and Environment Act, we hereby make application to amend the current planning permit application after the notice of the original has concluded.

A general summary of the proposed changes is as follows:

- Increase in the overall footprint of the proposed facility from 10ha to 16ha.
- Change in solar arrays from a fixed PEG array to tracking arrays.
- Inclusion of five (5) batteries along the northern edge of the facility.

To reflect the above changes, the supporting documentation has been amended to reflect the current proposal now before the Minister for Planning.
