Hi Joel,

I hope all is well, and hoping you can steward a couple of items within Council for AusNet.

For the new Connection Works that AusNet are currently progressing at their Glenrowan Terminal Station, AusNet is currently seeking to:

- Include a new legal point of discharge along Glenwest Lane; and
- Remove two trees along Glenwest Lane that were previously identified to be retained under the current vegetation removal permit.

**Tree removal:** I've attached a plan that includes the trees along Glenwest Lane that are proposed to be removed, as they now fall within the protection buffer of the transformer (and associated bund). We will shortly be making an application for the removal of the 2 x native trees via DELWP in accordance with the native vegetation removal guidelines. I have attached the application for reference and can further discuss with Council prior to submission if appropriate.

**Legal point of discharge:** Also in the attached plan I have included an indicative location along Glenwest Lane where AusNet is proposing a point of discharge for environmental water out of the oily water separator unit located at the transformer bund. If there is a person in council that we can discuss the point of discharge and requirements it would be greatly appreciated.

Please let me know if there anything else I can provide to support internal interactions.
