The Proposal	Description of the proposal:	This project relates to the Lower Sports Oval Precinct at the Coolock Campus, and will see the development of sporting ovals and adjacent building infrastructure. There will be four sporting ovals - one senior large size, one senior minimum size and two junior size, two outdoor netball courts, carparking and landscaping, and adjacent changerooms and amenities. The building, the outdoor courts and carparking will be located centrally in the oval precinct. The changerooms and amenities will be co-located with the Northern Rivers Regional Cricket Hub building, which will feature an elite indoor cricket training facility with six cricket pitches, two internal basketball courts, changerooms and amenities and office administration area. This application is for Stage 1 and Stage 2 of the proposed development. Further details are included in the attached planning report.
