Re: Application to Amend Planning Permit PA1700266-3 Amendment to Application before Notice Golden Plains Wind Farm

Thank you for your letter of 8 February 2021 requesting further information in regard to the submission of the application to amend the planning permit for the Golden Plains Wind Farm (the Project).

Golden Plains Wind Farm Management Pty Ltd (GPWFM) provides the following attached information in response to your request for further information pursuant to Section 54(1) of the *Planning and Environment Act 1987* (the Act) and also submits an Amendment to application before notice under Section 50 of the Act.

The amendments to the Amendment application include:

- The assessment of an additional wind turbine generator (WTG) model, known as the General Electric (GE) 6.0-164 WTG; and
- Correction to Condition 75 to reflect updated WTG numbering.

The details and supporting information of the amendment to the application before notice are detailed in the attached planning report.
